APPLICATION FOR CHARTER

TO THE HONORABLE, THE JUDGES OF SAID COURT:

Be it known, that the subscribers, all of whom are of full age, residents of the Commonwealth of Pennsylvania and Citizens of the United States, having associated themselves together for the purpose of organizing a non-profit Corporation under the name of "EAST READING SWIMMING ASSOCIATION OF READING, BERKS COUNTY, PENNSYLVANIA", and being desirous of becoming incorporated agreeably to the provisions of the Act of the General Assembly of the Commonwealth of Pennsylvania known and cited as the "Non-Profit Corporation Law", approved the 5th day of May A.D., 1933, as amended, do hereby declare, set forth and certify that the following are the purposes and objects of said Corporation:

1. The name of the proposed Corporation is: "East Reading Swimming Association of Reading, Berks County, Pennsylvania."
2. The location and post office address of the initial registered office in this Commonwealth is: "539 South 14th Street, Reading, Berks County, Pennsylvania".
3. The purposes of the proposed Corporation are to acquire, establish and maintain a swimming pool; to erect and maintain such other facilities required for the purpose of providing for the furnishing of refreshments, entertaining and social diversion of its members and for these purposes to have, possess and enjoy all the rights, benefits and privileges of the said Act of Assembly and its supplements; that it is an Association that does not contemplate pecuniary gain or profit; incidental or otherwise to its members.
4. The term for which said Corporation is to exist shall be perpetual.

ARTICLES OF INCORPORATION
